# PROJECT EXPENDITURES

All the expenditures reported here were incurred in the field, i.e., outside Canada, Plateau Perspectives' international headquarters. In two instances – the *Jiongqu health centre* and the *Muqu village school 2005* – the figures include both the cost of construction materials purchased in 2004 and funds allocated for project completion in 2005.

International staff time (fees) and international travel costs have not been included, as they have been donated by staff members.

Due to variable exchange rates, the figures below are approximate. Detailed accounts and receipts are held in Canada.
